1.	Excellence in Scaling-up of Manufacturing for COVID demand	To recognize the organizations which have increased indigenous manufacturing to meet the COVID demand	Open to all Medical device companies, Diagnostic manufacturers, Start-ups in India
2.	Excellence in Hospital Preparedness for COVID-19	To recognize the organizations which have increased/modified the facility, infrastructure, process, diagnostic center, supply chain, etc. to meet the demand of the current situation	Open to all Hospitals, Diagnostic Centre, Blood Bank and Other Healthcare Service Providers*
3.	Excellence in Home Healthcare	To recognize the organization which have taken initiatives to provide home healthcare services to patients so they get their treatment inside their home	Open to all Hospital and Other Healthcare Service Providers*
4.	Excellence in Telemedicine/ Digital Health	To recognize the organization which have taken initiatives to provide tele-consultation to their patients without exposing their staff and patients to virus	Open to all Hospitals and Other Healthcare Service Providers*

1.	Innovative Medical Device/ Technology	Any equipment, device or technology intended to use for medical purpose which healthcare providers to diagnose and treat patients to result in better healthcare in India. The technology must have been manufactured/adopted for commercial use after all regulatory clearances	Medical Technology/Device companies and Healthcare research institutes/ Start-ups
2.	Innovative MedTech Software/ App	To recognize organization which has developed an innovative medical software/ app for the healthcare sector in India to enable professionals to efficiently manage patients or spread awareness to people about COVID	Medical Technology/Device companies & Healthcare research institutes/ start-ups
3.	Excellence in Capacity Building	To recognize the initiatives taken by organization and employees to obtain, improve and retain the skills, knowledge tools, equipment and other resources required to treat the patients	Open to all hospitals, Other Healthcare Service Provider
4.	Excellence in Social Initiative	To recognize the social initiatives which have resulted in the upliftment of the healthcare status in India. The initiative should have wider impact on the preventive/ therapeutic and outcome-based healthcare scenario	Open to Corporates, Other Healthcare Service Providers, NGO's and Not for Profit Organisations

Award definitions

Special categories (Nomination by Jury)



Sr.	Award categories	Definitions
1.	Lifetime Achievement in Healthcare Industry	To recognize a person who has made significant impact on the Indian healthcare industry over his career. The award is for a well known and respected person in the healthcare industry who is the role model for current and future healthcare professionals
2.	Healthcare Personality	A person who has significant achievements during the past year in terms of business growth, mergers and acquisitions, positive regulatory change, betterment of academia, research, global expansion, etc.
3.	Healthcare Humanitarian	The award should recognize Social Activist with an outstanding contribution to healthcare segment in India. The social causes should have made a measurable impact for making quality healthcare available in India without any profit or business motive
4.	Special award for Doctor/ Nurse/ Other healthcare worker	To recognize the healthcare provider who is constantly treating COVID patients in every possible manner and making sure that patients are fit and healthy as soon as possible. The Award is to recognize their tremendous contribution and constant effort to make India a COVID free country

The organizations that have a registered presence and operations in India can be nominated and participate in the Awards by filling the application form pertaining to the category

The organization must have completed at-least 5 years of operations in India as on June 30, 2020. Any start-up applying for the awards should have completed minimum of 2 years and maximum of 5 years of operations in India as on June 30, 2020

The initiative/ unique treatment should have been completed and executed in the Indian operations of the organization in the period Apr 1, 2017 to June 30, 2020

Process Overview



Phase I – Pre -Jury

Discuss categories and process with Core group members & Awards management

Create scoring portal for the jury to score and evaluate the entries

Call for entries to be announced

Core group members to nominate under COVID-19 award categories

Phase I – Pre -Jury

FICCI & EY to reach out to nominations to fill the application forms

EY to do eligibility checks on the received entries and share daily eligibility report

Phase II – Virtual Screening Jury

EY to share the applications with jury members for evaluation before the virtual jury meet

Jury has to go through all the applications and submit scores before the virtual jury meet

Phase II – Virtual Screening Jury

EY to announce the Top 3/5 during jury meet based on jury scores which jury has to discuss and deliberate

Participants have to be available on call to answer Q&A

Phase III – Virtual Grand Jury

Grand jury to discuss Top finalists and determine winners
